REGULAR GIVING TO ST. ANDREW'S CHURCH

There are various methods of giving regularly to St Andrew's:-

1. Weekly envelopes, issued as a boxed set for a year

2. Standing Order through your bank

Once you have decided the frequency, payment date and amount to be given, quote the following information:-

3. One-off Gift Aid Envelopes

Some donors still prefer to place an envelope in a basket when attending church and if they pay tax can complete the declaration on the front of the envelope.

4. Payroll Giving

Payroll Giving is a scheme that employers can arrange with a Payroll Agency (PGA) for employees to give donations to a charity out of their gross pay or occupational pensions via the PGA.

An employer voluntarily arranges for a scheme with a PGA. The employees can then voluntarily authorise the employer to deduct a PG donation from their gross pay to be paid to the PGA and the PGA pays each employee's donation to their nominated charity or charities.

Any donations are deducted at source, before the income is taxed and cannot therefore qualify for Gift Aid.
